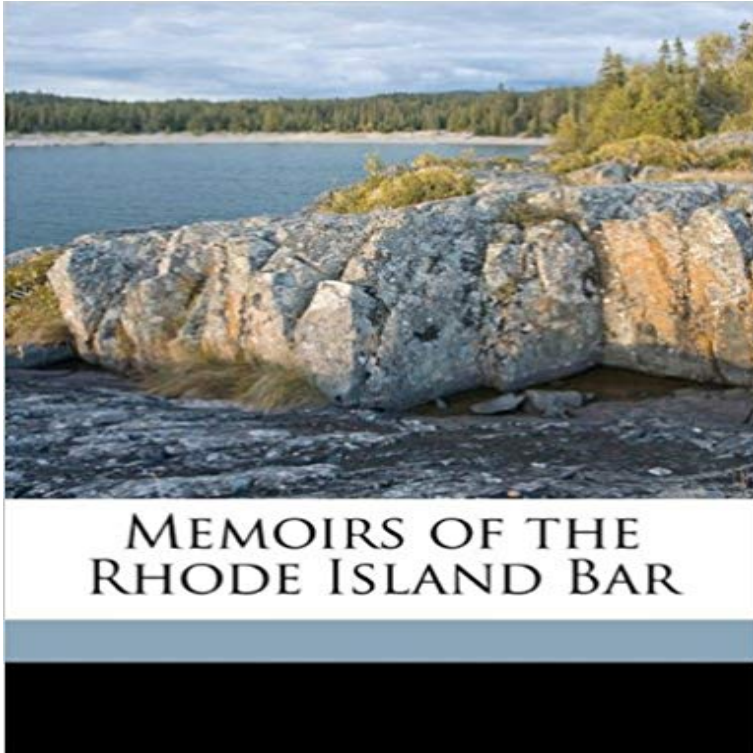


## Memoirs of the Rhode Island Bar
